PROJECT UPDATE: PROTECTED BIKE LANE ON N DENVER

Through the Portland Bureau of Transportation's (PBOT) Fixing Our Streets program, the city is repaving N Denver from N Lombard to N Watts. As previously announced, PBOT intends to re-configure this stretch of N Denver with a protected bike lane.

PBOT has been engaging neighbors about the project and presented a completed design (historickenton.com/bikelane) at the KNA meeting in April.

As shown in the design on the KNA's website, parked cars would be placed off the curb so that a protected bike lane forms between the parked cars and the curb. This stretch will also feature bus stop with improvements at N Russet St, and after some tweaking to add spots back, about 60% of parking remains.

The project was expected to move forward with construction starting in June, but the KNA hasn't received any additional updates from PBOT. REACH CDC'S DEVELOPMENT

Since their response to a request for statements of qualifications and presentation to Kenton residents in June of last year, REACH CDC has had to make changes to their planned housing development of TriMet's property at 2133 N Argyle St across from Nelson Plaza due to a funding gap of roughly 4 million dollars.

Besides moving to 100% affordable housing to better align with REACH CDC's charter, the project is also set to be completely residential without any ground-floor commercial space.

Without retail space, the project would be able to bypass Oregon's prevailing wage law using an exemption for affordable housing, which reduces the project's labor costs enough to close REACH CDC's funding gap.

Hoping to keep the project moving forward, TriMet lifted the commercial activity requirements for the project to allow REACH CDC to be able to use the prevailing wage law exemption.

Feeling that without any ground-floor commercial this site would be disconnected from the Kenton business district, lack a transit-oriented focus and fail to activate the "gateway" to the neighborhood, the KNA took various actions to attempt to find additional funding for REACH CDC to restore the commercial component. However, those attempts were unsuccessful.

REACH CDC is still awaiting funding awards to fully fund the project as completely residential and will be presenting at the KNA General Meeting on June 13.

KENTON WOMEN'S VILLAGE (KVW) UPDATE

The KNA Board unanimously voted to refer the question of extending the Kenton Women's Village (KWV) beyond the initial one-year duration that expires in June to a neighborhood vote at the next General Meeting on June 13 from 6–8:00pm at DISJECTA (8371 N Interstate Ave).

While the city-owned land used for the KWV remains under contract to be sold to Transition Projects Inc (TPI) to build low-income housing, that development is running about 6 months behind schedule, allowing the opportunity for the

KWV to extend its operation. The KNA Board intends for neighbors to consider approving up to another year of the KWV in case TPI experiences additional delays.

However, before finalizing plans to go past the current June closing date, project organizers for the KWV have vowed to only continue on with Kenton neighborhood support.

The KNA Board also granted a conditional extension for the KWV to occupy the site for 3 additional months in case the neighborhood votes against continuing the project. This would allow Catholic Charities, who manages the KWV, to continue normal operations until the neighborhood vote with time to wind down the project if the vote fails.

KWV by the Numbers

Of 24 former and current KWV residents, 14 women have already moved from the village into permanent housing with the assistance of Catholic Charities case managers. A second cohort are now rotating through the village.

"It's a journey for each of them," says Margie Dechenne, program manager at Catholic Charities Housing Transitions Program. "The secret sauce in this is the sisterhood they have found, the friendships, the ability to be safe and secure, to engage with our case managers, and to contribute back to their community. They are so very grateful to the Kenton neighborhood for this opportunity."

The average age of the villagers is 47.5, and the average time they had been homeless is 4.5 years with a range of 1 to 20 years.

Before joining KWV

- 18 women had no reliable transportation
- 10 had no personal identification
- 6 had no way to receive a phone call
- 19 had no regular income
- 7 had no health insurance
- 16 had significant interactions with hospitals, emergency rooms, and ambulance transports
- 16 reported not going for medical treatment when they felt ill
- 20 reported having serious health issues

Since joining KWV

- 20 receive monthly bus passes
- 15 have personal identification
- 6 have received free phones
- 12 are enrolled in benefits programs
- 5 are receiving financial wellness coaching
- 7 are enrolled in Rent Well curriculum
- 3 are enrolled in a financial match saving program
- 100 % have enrolled in health insurance and have a primary care doctor with student nurses from the University of Portland also visiting twice per week
- 1 has visited a hospital's emergency department
- 0 ambulance calls
